(NYSE: S), in a merger transaction. In connection with the merger, Velocita Wireless will lease certain FCC spectrum channels from various affiliates of Sprint Nextel Corp., subject to any required FCC approvals.

Headquartered in Woodbridge, NJ, Velocita Wireless operates a nationwide Mobitex[™] wireless data network covering 93% of the U.S. business population that delivers data communications solutions_± including email messaging, machine-to-machine (M2M), telematics, point-of-sale, and telemetry applications to its approximately 200,000 customers
